**TRUST - DEED**

This CHARITABLE TRUST has started on 15th day of April 2005.

1. That the executant hereby transfer into the trustees absolutely and for ever the sum of Re. 2100/- (Two Thousand One Hundred Only) in mentioned in the Schedule here to hold the same in trust for the executant and for purposes mentioned hereinafter.
2. That the trust here created shall be known as SHRI PURAN LAL CHICKAR MEMORIAL EDUCATIONAL & CHARITABLE TRUST and its office shall be at 113, Civil Lines Bareilly (Which will only to be used as office and is not to be gifted to the trust) and at such other place(s), which the trustees may mutually decide from time to time.
3. That the executant has given a total sum of Rs.2100/- (Rupees Two Thousand One Hundred only) through Ch.No.349074 Dated 15.04.2005 of Bank of Baroda, Shyam Ganj, Bareilly, as mentioned in the Schedule which the trustees shall deposit in the Schedule Bank or invest the same in interest bearing securities. It will also be open to the trustees to accept donations in cash or kind or of movable or immovable properties from any person, firm, company or institution and the like.
4. The trust being established hereby shall be irrevocable and no part of the Trust Fund shall in any circumstances whatsoever, be paid or lent to or be applied for the benefit of the Settlor or wife of the settlors or any person for the time being a minor child or relative of the settlor.
5. OBJECT OF THE TRUST:

That the interest or other income which will accrue to the Trust from out of the Trust money or properties after defraying all costs and expenses of or incidental to the administration of the Trust Fund, shall be applied for the following purposes irrespective of cast, creed and colour:-




- (a) To open, start, run and maintain Educational or Charitable Institutions for the benefit of general public in India and to do necessary act to affiliate the trust with any Board.
- (b) To propogate ideals & examples of 'RAMAYAN' and other spritual and scriptures books.
- (c) To lay special emphasis on the development of Hindi language for which to organise Seminars, Meetings, Promotion Programmes, Distribution of Literature, establish Libraries, open & maintain Hindi Bhawan and to do every possible thing for the promotion and upliftment of Hindi & Sanskrit language for the benefit of general public in India & abroad.
- (d) To open, start, run & maintain Ashrams, Dharamshalas, Jalashalas, Temples, Hostels and any other such institutions for the benefit of general public in India.
- (e) To print and publish the moral, spritual and social development literature & book for the benefit of general public in India & abroad.
- (f) To do every activity for the moral, spritual & social Development and to organise cultural Dramas, Sports, music, Dance & other programmes to the best traditions of Indian culture.
- (g) To provide stipend, scholarship and prizes to the students and to help students by adoption to bear the cost of the primary as well as for the higher technical education of the students in India & abroad.
- (h) To provide Medical relief, medical facilities, to open & maintain homes for widows, Aged persons, orphans and handicapped, to open & maintain Hospitals and to do any other charitable work in general without any distinction of caste, colour or creed for the benefit of general public in India.

- (j) To help poor and needy for the benefit of general public in India.
- (k) To donate and to receive Donations to and from other charitable organisations.
- (l) To take over the other Educational, charitable or religious trust, society or institution, if other educational, charitable or religious trust, society or institution is not able to manage the affairs properly and if desire so.
- (m) To do any activity or any bussiness relating or incidental to the objects mentioned supra or otherwise not prohibited by law of land.
6. (i) To get help from the Government, local Bodies and other sources & institutions for the above mentioned purposes.
- (ii) To purchase or acquire property both movable & immovable, land or Building on lease or in exchange or by Gift or otherwise of any real or personal property or rights or, privileges necessary or convenient for the objects of the trust at a suitable site.
7. That trustees shall by themselves or/and through agent/agents manage, sell, purchase and deal with the trust property in manner as might be most beneficial to the interest of the Trust and they shall likewise realise the interest, dividend, rent of the trust property and shall apply the same for the purposes aforesaid.
8. That, if at any time, the trustees find that the income of the trust property is not sufficient for the objects of the trust as hereinafter mentioned they shall be at liberty to draw upon the principal sum of the trust or to raise money by disposing of such stocks, shares or securities or property movable or immovable as may then be available with the trust utilising it only for the purposes of the TRUST.

9. That in order to raise funds for the Trust from public/Bank or any Institution, the trustees will also be entitled to invest the funds of the Trust in such business or/and investments as they may mutually decide.
10. The trust shall be managed by the Managing Trustee who will look after the trust management as a whole. The first Managing Trustee shall be Shri Rajesh Chickar. According to the expansion of the trust activities, other trustees could be appointed as Manager of its each unit separately and/or collectively as may be decided from time to time.
11. The trustees can be appointed by passing resolution by the majority subject to maximum number of 3/4 of trustees as may be decided according to the needs of the trust from time to time.
12. That in the event of any vacancy arising, amongst other trustees either by death, resignation or other infirmity, the appointment of new trustees shall be made at a meeting called for the purpose by the remaining trustees who shall make the appointment by the majority opinion of the trustees when present, and pending such appointment the remaining trustees shall continue to administer the trust. In any such meeting in case the votes for and against are equal, the chairman will have a casting vote.
13. That in case of any difference of opinion at any time exists between the Trustees for the time being in relation to the Commission or omission of any act or otherwise however in execution of the trust of this deed, the opinion of the majority of such Trustees shall prevail, provided that in the event of the tie between them the Chairman of the Trust shall have a casting vote in addition to his/her own.
14. That the account of the Trust shall be regularly maintained by the Trustees at the office of the Trust and such accounts shall be closed every year and properly Audited.

15. It shall be lawful for the trustees for the time being of these presents to reimburse themselves or himself or herself or pay and discharge out of the trust properties of costs, charge and expenses incurred in carrying out these presents or in or about the execution of trusts or powers of these presents.

16. **POWER OF TRUSTEES:**

The Trust as well as the Trustees according to the rules would have the following powers viz:-

- a) To receive and accept gifts and donation of properties of all kinds, whatsoever and wheresoever, whether subject to trust or not.
- b) To purchase, take on lease, exchange, or otherwise, acquire properties movable as well as immovable, whatsoever and wheresoever and to erect and construction super structures on them.
- c) To invest the funds of the trust (not immediately required) in securities or deposit them in Schedule Bank.
- d) To borrow money on security/mortgage or otherwise.
- e) To open and maintain Bank accounts which will be operated as decided by Board of Trustees.
- f) The Trustees will have the power to let out, lease or otherwise transfer all movable and immovable properties.
- g) To frame rules and bye-laws for the carrying out of the objects of the Trust.
- h) For administering the properties of the Trust, for residence and enjoyment by scholars, trainees aspirants etc. and for all other purposes relating to the Trust and its activities.
- i) The trustees shall have all other and full & unrestricted powers as may be necessary or incidental to the carrying out of the objects of the trust.

17. That the trustees shall hold at least one meeting each financial year for purposes of managing the trust. The quorum shall require four trustees present in the meeting.

18. The Trustees shall have power to regulate their proceedings

and if necessary, to frame rules and regulations for any purpose and/or in connection with meeting, membership of trust and/or from time to time repeal, amend, add to or alter the same.

19. To frame Advisory or any other committees or Board and to appoint members or chairman out of Trustees or from public for the smooth running of Trust so that objects of the trust can be achieved properly.

20. DISSOLUTION:

If upon the dissolution of the Trust, there shall remain after the satisfaction of all its liabilities, whatsoever the same shall not be made to or distribution among the members but shall be given to some other trust or institution having objects similar to the objects of the trust to be determined by the votes of not less than 3/5 of the members of the board or in default thereof by such Judge or court of law as may have a required jurisdiction in the matter.
